Promotion Official Rules ("Official Rules")

 - e. Your Photo does not contain any pornographic, obscene, defamatory or other content prohibited by these Official Rules;
 - f. Use of the Photo by Sponsor, as contemplated by the Official Rules, will not infringe any copyrights, rights of publicity, rights of privacy, or any other rights of any person, living or dead.
 - g. Your Photo is not subject to any prior agreements that would limit the scope of the permission granted to Sponsor under the Official Rules;
 - h. You have complied with all relevant laws, rules and regulations in the production of your Photo; and
 - i. Your Photo has not been entered into any other contest or promotion.

Sponsor reserves the right, in its sole discretion, not to post or to require removal of any Photo that it believes violates these Official Rules, the law, or the rights of any person or is otherwise inappropriate for a promotion of this nature.
